

YogaJardin Prenatal Yoga Teacher Training and Courses Terms and Conditions:

Prerequisites:

Practice & Experience

Students should have been practicing yoga on a regular basis for a minimum of two years prior to embarking the course.

This course is only open to qualified yoga teachers (Minimum 200Hrs) and yoga teachers trainees with an understanding of Viniyoga principles would be a plus but not a requirement. (If the student is not quite at the level required, the student may be asked to attend to 121 private tuition or to attend my classes.)

Booking & Refund Policy

A non-refundable deposit of £200 is required to secure your space on the course and should be paid on registration. Space is limited so Applications will be taken on a 'first come first served' basis.

The full Payment of £650 or £600 (Early Birds Offer) should be paid [14] days before the beginning of the course.

The Payment is non-refundable or transferable after the purchase, we do not offer any refunds.

YogaJardin is reserving the right to refuse a place to students who have not paid their deposit or full fees by the required date.

Courses will only run if there are sufficient numbers, in which case you will receive a refund for the full value of your course.
